The owner of Looe Country Park made a presentation outlining her objection to the above scheme.

The Chairman thanked her for her time and confirmed the Parish Council have objected to the scheme.

The Chairman said this could be looked at if the Community Governance Review accepts the Parish Councils proposal to redraw the Parish Boundary to include this site which currently is in Morval Parish.
