This application was discussed at the Parish Council meeting on 1st November. Only three Councillors could comment due to Declarations of Interest and absenteeism.

Due to the complex nature of the lease, Section 106 and broken verbal agreements between the leaseholder and the owners on the site, it was decided to ask our County Councillor to call this application into the Planning committee to decided.

Failures by various parties including the former District Council have caused this issue to arise and all of these need to be taken into account when considering the application.

The Parish Council have sympathy with the applicants who are only trying to secure their future home, but feel this is too complex for the Parish Council to simply approve. We do feel the demands for payments by the landowner to 'turn a blind eye' are unacceptable and it's time this was sorted out once and for all.
